Special Meeting

The Commission of the City of Mangum met in special session Monday, June 8, 2020, at 5:00 p.m. This session was held via Videoconference in accordance with the State of Oklahoma Statutes.

Mayor Scott called the meeting to order at 5:00 p.m.

3. Discussion and possible action to approve Resolution no. 2020-41 amending the FY20 budget for the General and Golf Fund.

Motion by REESE and seconded by BOWMAN to approve Resolution no. 2020-41 amending the FY20 budget for the General Fund and Golf Fund.

Webb wanted to know what the amount is. This amendment will only take to us through June 30, 2020. Mike Painter from West Texas Turf stated that the big problem is the sprinkler system. There has been a lot of work that has been done to the water system and has now seeded the greens. Webb asked if we need to be talking about this now and City Manager Andren stated that we need to have it to pay the rest of the contract out.

Mayor Scott called for the vote recorded as follows:

4. Report from West Texas Turf regarding the current situation at the Golf Course. (Greg Daugherty, West Texas Turf)

Mike Painter stated that they have swapped out all the heads on the sprinklers. The sprinkler heads were not big enough to handle the watering the golf course needs. The seeding is done and should be mowing grass with the next 14 days. Greens should be ready to open in October or November.

5. Discussion and possible action to amend the Golf Contract with West Texas Turf. West Texas Turf said keeping the contract at \$7,900.00 a month without the use of inmates. West Texas Turf said that they have crunched the numbers and feel like keeping the cost at the \$7,900.00 and even be able to purchase some equipment. The contract is up in January and will take effect at that time for two (2) years.
