5. Financial report by the City Manager.

The City Manager gave his report as follows:

Sales Tax is down by 2.16% from last month and up by 0.78% from the same month last year. The use tax is down by 20.99% from last month and down by 12.82% from the same month last year. Other revenues are up 2.61% from last month and down by 50.96% from the same month last year. Transfers-in from MUA are the down by 27.90% from last month and down 27.90% from the same month last year.

Overall revenues are \$162,382.90, which is down by 16.14% from last month and down 29.41% from last year. Expenditures are \$180,262.44 which is down by 27.95% from last month and up by 11.70% from the same month last year. Leaving the fund balance for the month at a negative \$17,879.54.

MUA Revenues were \$454,242.77 which is up by 23.68% from last month and up by 15.75% from the same month last year. MUA expenditures were \$417,792.25 which is up by 17.93% from last month and up by 6.11% from the same month last year. Leaving the fund balance for the month a positive \$36,450.52.
